PRIVACY POLICY

In general when you visit our web site you remain anonymous. We do not require you to register or provide personal information to us to view our site. We will only collect personal information which you knowingly provide to us by purchasing from our brick & mortar store, on-line store, renting tabletop items/equipment from Fancy That, or some other voluntary action on your part, such as contacting us by telephone or email.

Because your privacy is important to us we want you to know that unless required by law to do so, we will not sell, rent, share or disclose to third parties any such personal information in any way other than what we represent in this privacy policy. Any such information obtained by us will be used only for the following purposes:

1. We may request contact information (like name, shipping address, telephone number and email address). This information is used to respond to your inquiry, or fulfill your merchandise or rental order. If we have trouble or questions in connection with processing your order, your contact information is used to contact you.
2. We may also use this information to notify you from time-to-time of upcoming events, new products available in our gift shop, special sales or other offers made by Fancy That. 3. Occasionally, we may make personally identifiable information available to other organizations that we feel may be of interest to you, unless you request otherwise.
